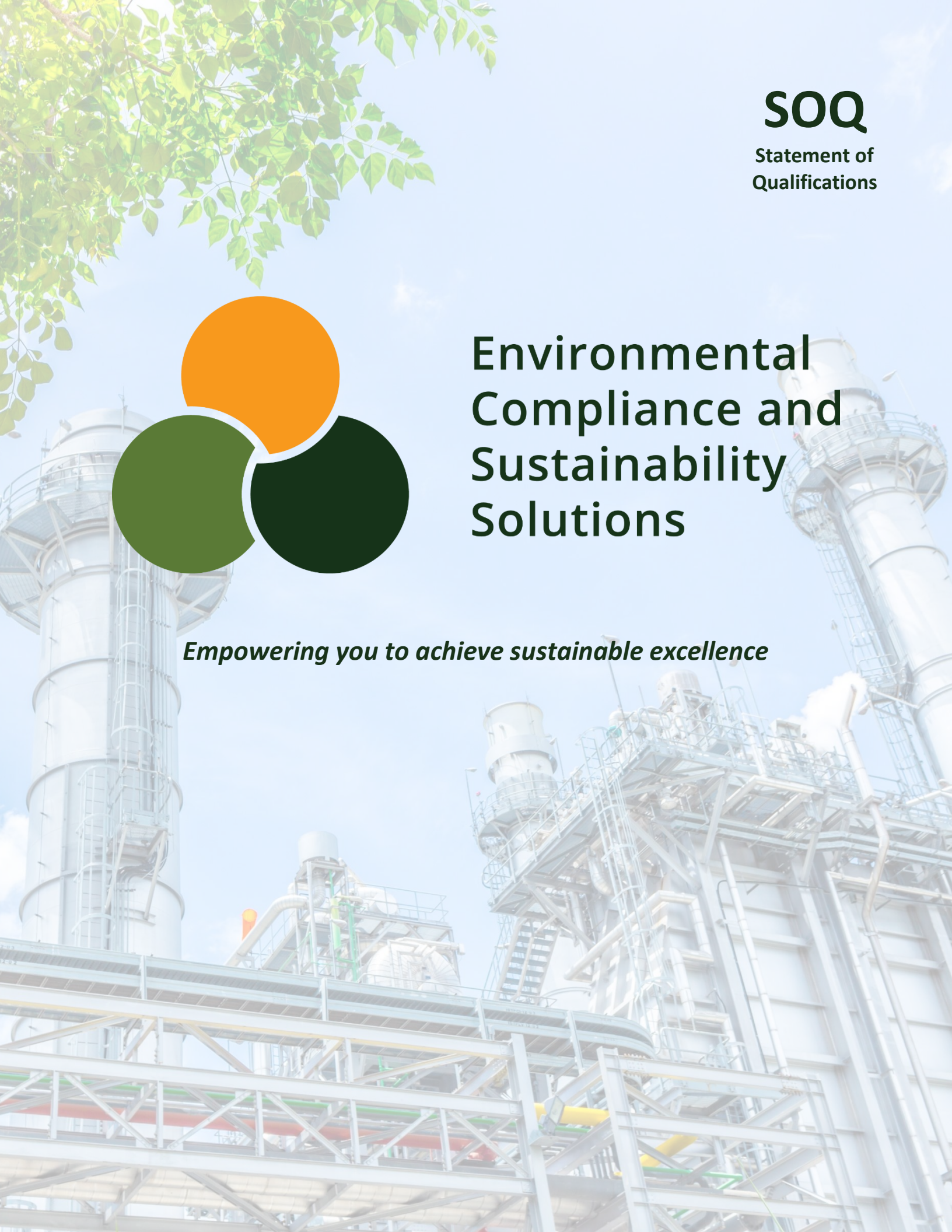

Everyone in your organization should work according to your management system documentation, which means setting this new expectation with training. ECSS can help by preparing and executing the training for your staff.

Step 4: Pre-Certification Audit

Before your certification audit, doing a practice run is a good idea. This familiarizes your staff with the process of an audit – practice makes perfect! ECSS can conduct this audit or train a staff member in your company to conduct an audit.
